AFTER THE EASEMENTS ARE RECORDED, OWNERS ARE BOUND BY ITS TERMS IN PERPETUITY. DURING THE YEAR ENDED JUNE 30, 2018, MALT EXPENDED \$12,981,460 TO ACQUIRE 5 CONSERVATION EASEMENTS. MALT STAFF VISIT EACH EASEMENT ANNUALLY TO MONITOR CONDITIONS AND ENSURE COMPLIANCE.
